Dear Mr. Ponce and Ms. Wainwright:

As you may know, Michele Liberis was sued by Green Bullion Financial Services, Inc. d/b/a Cash4Gold ("Cash4Gold"). While Ms. Liberis was unrepresented by counsel, Cash4Gold secured an Injunction against Ms. Liberis which requires Ms. Liberis to take steps to remove any articles which she may have posted regarding Cash4Gold. In order to comply with the Injunction, Ms. Liberis hereby requests that both The Consumerist and ComplaintsBoard.com remove any postings concerning Cash4Gold from their websites.

Please note that Ms. Liberis continues to stand behind all statements which she may have made to third parties regarding Cash4Gold.com, and believes that the Injunction, which essentially prohibits her from disclosing Cash4Gold's wrongful conduct to the consuming public, was improperly entered. Ms. Liberis intends to seek dissolution of the Injunction in the near future for various reasons. Notwithstanding, so long as the Injunction is in force, Ms. Liberis will comply with it, and therefore asks that you comply with her request remove any articles on your websites concerning Cash4Gold.


